Stefan, Susan – “Legal and Regulatory Aspects of Seclusion and Restraint in Mental Health Settings”

1. After the *Hartford Courant* reported on 148 deaths nationwide in ten years, Congress held hearings and passed legislation designed to prevent these occurrences. Between July 1999 and December 2001, however, the Center for Medicare and Medicaid Services received reports of 70 deaths in restraints from 24 states and Puerto Rico. Urban, P. (May 6, 2002).
