

### Statewide Family Network Grants History

• The Statewide Family Networks started with 5 grantees for \$20,000 and grew to 46 states being funded and currently there are 29 grantees receiving \$95,000 a year for three years.






## Statewide Family Network (SFN) Basics

- SFN funding began in 1988.
- They began because the federal government recognized the need for family voice in policy development.



- o information, education, and support to families who have children with mental health issues and part of the work of providing information is to inform and educate policy makers concerning the needs of families raising children with mental health needs.
- The SFN grant cycle is 3 years.





## Statewide Family Network Grant Requirements

#### Requirements include:

- The grantee must be an independent 501-c-3, NOT functioning under an umbrella organization.
- 51% of the organizations board of directors
   MUST be made up of family members who are
   CURRENTLY raising a child with a serious
   emotional disorder.
- The grantee in their application must sign a certificate as to the validity of points A and B.
